INTRODUCTION

HOW THE PROGRAM WORKS:

ELIGIBILITY AND ENROLLMENT



\$0 Copays

There are no copays or fees for members to join the program.



Simple Enrollment

To enroll, members complete a brief health screening questionnaire and participate in a quick 5-minute physician consultation to verify prescription eligibility.



Annual Renewal

To maintain enrollment, members will have an annual consultation (video call or phone call).



PRESCRIPTION PROCESS



Health Screening Questionnaire

Members receive a secure health screening questionnaire

Telehealth Physician Consultation

5-minute telehealth physician consultation

Prescription

A copy of the member's original prescription is a sent to the pharmacy for fulfillment and shipping

Follow-Up Call

A follow up call is scheduled within 30 days

DISCLAIMER:

340B medical providers do NOT replace the member's existing doctor but will clone the original physician's prescription (e.g. drug, strength, instructions, quantity including refills) to ensure continuity of care.



3 COVERED ENTITY RELATIONSHIP

To get medications through the 340B program, patients must be treated by a healthcare provider or facility that's part of the program. This program is overseen by a government agency called HRSA.

MEDICATION AVAILABILITY

The program offers a wide range of medications, including brandname and specialty drugs, available through a centralized platform at discounted rates.

BENEFITS OF THE 340B PROGRAM

- **\$0 copays:** Zero out-of-pocket costs for members.
- Employer savings: Save up to 50% on Rx costs.
- No Impact on Primary Care Providers: The program does not replace existing relationships with primary care doctors or specialists, ensuring continuity of care.
- **Improved Medication Adherence:** By lowering medication costs, members are more likely to follow their prescribed treatment regimens, improving health outcomes.


